

The solution, designed and developed by Confinale, provides a direct linkage of Investment Navigator product suitability data with core Avaloq functionalities such as order validations and reports. The Investment Navigator rules are integrated in the Investor Protection Module of Avaloq, by providing a specific Investment Navigator rule service as part of the Investment Suitability Framework (ISF) and they are updated on an ongoing basis. This new rule-service can be integrated into the existing kernel functionality of Avaloq, namely the Applicable Offering rule service, complementing any bank-specific checks.


